## Dear Sir/Madam

With reference to your request for information received on 17<sup>th</sup> October 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. For the 4 months from May to August 2024, how many <u>unique</u> patients received the following intra-vitreal treatments for any eye condition:
  - **Aflibercept** = 523.
  - Bevacizumab = 16.
  - **Brolucizumab** = 0.
  - Dexamethasone = 34.
  - Faricimab = 425.
  - Ranibizumab Lucentis = 34.
  - Ranibizumab Ongavia = 0.
  - Ranibizumab Ximluci = 9.
- 2. For the patients above, how many were new to intra-vitreal treatment? Please provide the patient numbers by the treatments listed below, excluding patients who previously had received any of these treatments.
  - Aflibercept = 43.
  - Bevacizumab = <5.
  - Brolucizumab = 0
  - Dexamethasone = 0.
  - **Faricimab** =45.
  - Ranibizumab Lucentis = 0.
  - Ranibizumab Ongavia = 0.
  - Ranibizumab Ximluci = <5.

The Trust has a policy of not releasing information when the data involved is less than 5. This is because we feel that such low numbers could make the individuals involved identifiable and therefore may cause undue harm and distress.

To disclose this information would:

- a) Contravene the Data Protection Act principles in that it would amount to unfair and possibly unlawful processing, as there was a legitimate expectation by the third parties that this information would remain confidential, and
- b) Disclosure may cause damage or distress to the individual(s) involved, and that damage or distress would be unwarranted (section 10 of the DPA).

If we do not hear from you within 40 days, we will assume that we have been able to accommodate your request under the Freedom of Information Act 2000.
