With reference to your request for information received on 28th October 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I would be grateful if you could send me two datasets from your Trust:

(1) SACT Cancer report

An extract from the chemotherapy ePMA system showing patients treated by drug and diagnosis, as specified in table 1 (below).

We are unable to provide this information as the information is not held in a reportable or structured format in our central system and records would have to be reviewed manually which would exceed the appropriate time limit. The Trust has to take into account the cost attributable to the time spent in locating, retrieving, and collating the information. We have therefore applied exemption Section 12 (4) (b) of the Freedom of Information Act 2000-beyond appropriate limit. The appropriate limit is set at £450.00 (18hrs @ £25 per hour).

The Trust treats over 120 cancer patients per week and would need to access 4 different systems in order to compile this information. Therefore, this would exceed the appropriate limit of 18 hours.

(2) Drug Patient Level Contract Monitoring (DrPLCM) report

Data fields from the DrPLCM report, as specified in table 2 (below). Please do not send patient IDs or cost data, as I appreciate this would compromise data privacy and commercial sensitivity.
