- 1. Number of Multi-functional devices at Wrightington, Wigan & Leigh NHS Foundation Trust? The Trust has 223 MFD's, 275 printers with 27 MFD's and 31 printers in the community.
- 2. Name of current supplier/s?

Canon.

3. Contract start date and length of contract?

Start date: 02/09/2024 Length of contract: 3 years.

4. Contract end date?

5. Is there an option to extend this contract?

Yes.

6. Does the Trust have a print room? If yes, when does the contract end?
