#### How many mammography examinations have taken place in the last 12 months?

There have been 30,452 Screening Mammograms and 5,387 Symptomatic Mammograms completed; totalling 35,839 Mammograms completed across the service.

This figure does not include the 1,520 Tomosynthesis.

## How many of the above patients received contrast media enhanced mammography?

None - We do not currently provide contrast enhanced mammography.
